UPDATED Quarantine & Isolation Guidance (1/21/2022)

ISOLATION – Positive Case

Follow guidance for Quarantine for Students in K-12 Schools	 Stay home for at least 5 days (unless you qualify for DO NOT QUARANTINE below) after the last close contact with the person with COVID-19 (Day 1 is considered the first full day after the date of last close contact) If no symptoms, get tested at least 5 days after the last close contact. If the person tests negative, they may return to school or child care IF they wear a well-fitting mask when around others* until 10 days after their last close contact; If the person is unable to get a test, they may return to school or child care after Day 5 IF they wear a well-fitting mask when around others* until 10 days after their last close contact. If the person is unable to mask around others, they should remain at home for 10 days from the date of last close contact. 	5-day quarantine protocol can be utilized for all children who are 2 years of age and older who can consistently mask wear throughout the day. Children returning to daycare on Day 6 will need to be monitored by daycare staff to ensure they are wearing their masks appropriately. If they are unable to properly wear a face mask, they should not return to daycare until they complete a full 10-day quarantine.	

NOTES:

- 1. For children who return 6 days after the onset of infection or following exposure to a person with Covid, the only times that masks may be removed are when a child is outdoors, eating, or taking a nap. During meal or nap time, children should be at least 6 feet away from others.
- 2. Any child returning earlier than a full 10-day quarantine should be carefully monitored for symptoms of illness. If they display any signs of illness, they should be picked up by their parent/guardian as soon as possible and tested for Covid.
- 3. In keeping with earlier guidance, children under 2 years of age should not wear a mask due to the risk of suffocation. These children will continue to require a full 10-day isolation or quarantine period.

The health department's processes for notification as well as isolation/quarantine protocols will change effective immediately.

- Questionnaires filled out for symptomatic, positive, or close contacts to a positive will still be required.
- Rosters will no longer be required unless there are children in the room who attend in person learning at a public or non-public school. In those circumstances, the CCHD daycare team will require a roster to be submitted at the time of the questionnaire submission.
- At this time, we will be sending closure/quarantine letters to the daycare facility/owner only and THE DAYCARE OWNER/DIRECTOR WILL NEED TO DISTRIBUTE IT TO PARENTS in the mechanism by which the daycare typically communicates with families.
- We will no longer send out individual quarantine letters to parents.
- A notification will still be sent to the licensing specialist when a closure occurs.
