Follow guidance for Quarantine for Students in K-12 Schools	<ul> <li>Stay home for at least 5 days (unless you qualify for DO NOT QUARANTINE below) after the last close contact with the person with COVID-19 (Day 1 is considered the first full day after the date of last close contact)</li> <li>If no symptoms, get tested at least 5 days after the last close contact.</li> <li>If the person tests negative, they may return to school or child care IF they wear a well-fitting mask when around others* until 10 days after their last close contact;</li> <li>If the person is unable to get a test, they may return to school or child care after Day 5 IF they wear a well-fitting mask when around others* until 10 days after their last close contact.</li> <li>If the person is unable to mask around others, they should remain at home for 10 days from the date of last close contact.</li> </ul>	Quarantine Under 5: Children under 5 (vaccine ineligible) will need to do a 10 day quarantine after an exposure to a COVID positive person if they do not develop symptoms. They may not test out of quarantine. If they test positive during quarantine, they will begin their 10 day isolation period.
