New Eyes transforms the lives of children and adults facing financial hardship across the United States through the simple, yet critical, tool of new eyeglasses.

New Eyes assists individuals in the United States, who have no other resources, to obtain a basic pair of eyeglasses free of charge.

- Applicants pay no out-of-pocket cost but must provide proof of need. Anyone living at 250% or less of the Federal Poverty Guidelines is eligible to receive New Eyes glasses. This requirement aims to provide services to the working poor, people with no health insurance, as well as those who have insurance but with no – or limited – vision coverage.
- People are eligible to receive glasses through New Eyes once every 12 months. Children automatically receive two pairs of glasses.
- Social service agencies/health advocates apply on a client's behalf. New Eyes provides a basic pair of single or lined bifocal lenses at no cost to the client. Special requests including upgrades such as progressive or Transition lenses are beyond the scope of New Eyes' program.
- Applicants must have an eyeglasses prescription dated within the last 24 months, including their pupillary distance (PD) measurement before applying.
- Our new state-of-the-art Virtual Try-On allows e-voucher clients to choose the correct frame for their face. This function is easy to use and ensures applicants get the right fit for their corrective glasses.
- Glasses can be shipped either directly to the client or to the agency that placed the application.

How We Do it:



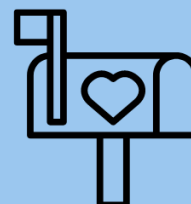
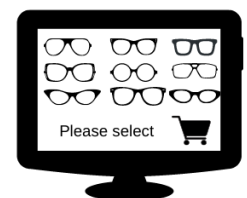
1) THE REFERRING CASEWORKER REGISTERS ONLINE FOR NEW EYES' NEW PRESCRIPTION EYEGLASS PROGRAM FOR U.S. RESIDENTS AND SUBMITS APPLICATION ON BEHALF OF CLIENT(S).

2) NEW EYES STAFF REVIEW APPLICATIONS ONLINE, CHECKING ELIGIBILITY AND GUIDELINE ADHERENCE.



3) WHEN AN APPLICATION IS APPROVED, A UNIQUE VOUCHER NUMBER IS EMAILED TO CASEWORKER WITH A LINK AND INSTRUCTIONS ON HOW TO ORDER GLASSES ONLINE WITH OUR OPTICAL LAB PARTNER.

4) THE CASEWORKER AND CLIENT CHOOSE FRAMES, INPUT THE PRESCRIPTION AND ORDER GLASSES. CHILDREN AUTOMATICALLY RECEIVE TWO PAIRS OF GLASSES.



5) THE GLASSES ARE MANUFACTURED AT THE LAB AND THEN MAILED TO THE SOCIAL SERVICE AGENCY OR TO THE CLIENT WITHIN 5-7 BUSINESS DAYS.
