

## School Health At-A-Glance

- Best practices to prevent the spread of **all illnesses**
  - Encourage proper hand washing with soap and water
  - Model and encourage proper cleaning/disinfecting of surfaces
  - Emphasize staying home when sick to faculty, staff, and students
  - Provide ventilation in the school building
  - Remind parents to contact their health providers
  
- COVID-19 Specific Reminders
  - COVID-19 is no longer a Public Health Emergency (PHE)
  - The Center for Disease Control (CDC) recommends
    - If an individual tests positive, that individual should isolate for 5 days and wear a well-fitting mask upon return
    - Individuals exposed do not need to quarantine, but can wear a mask
  - Reporting
    - Maryland
      - Single cases can be reported to the local Health Department via phone call
      - Outbreaks\* must be reported to the local Health Department and schools must engage with the Health Department about mitigation strategies
    - DC- report large numbers of cases (at least 25 cases tied to a single event)

*Types of Outbreaks	Description of Outbreaks
Cohort Outbreak	<u>Three or more</u> laboratory-confirmed COVID-19 cases among students/teachers/staff in a specified group with onsets (or, if asymptomatic, collection dates) within a 14-day period, and who are epidemiologically linked in the school setting, but not household contacts.
School Outbreak	<u>Five or more classrooms or cohorts</u> with cases from separate households that meet the cohort outbreak definition that occurs within 14 days; <b>OR</b>  5% or more unrelated students/teachers/staff have confirmed COVID-19 within a 14 day period [minimum of 10 unrelated students/teachers/staff].
Child Care Center Outbreak	<u>Two or more</u> COVID-19 cases among staff or attendees with onsets (or, if asymptomatic, collection dates) within a 10-day period, and who are epidemiologically linked, but not household contacts.

- Over-The-Counter (OTC) Tests
  - Maryland Schools can request OTC test kits
  - DC and MD residents can check with their local health department or pharmacies
