Important Information

1. After your application is submitted, you will need to upload financial documentation. This may include 2022 federal tax forms or other financial documentation as pertains to your circumstances, W2s, most recent pay stubs, and documentation about stated debt.

2. You do not need to complete an application for each child. You will add all students to one application.

3. <u>Check your email!</u> TADS will contact you via email if they need more information from you or encountered an error. If any information or documents are missing your application may not be considered.

4. There is no maximum income amount.* Every family has a unique financial situation that will be considered.

5. 5. All documents must be submitted by the due date for the application to be considered.

6. Decisions are expected to be emailed by the end of March/beginning of April. They will be emailed to the address used in TADS.

7. If you have questions about your application or need to make changes, contact TADS customer support. They are the only ones that can make changes to an application.

8. Maximum award amount for K-8 schools is \$1,500, Archbishop Carroll* is \$2,400, and Independent High Schools is \$500

9. If you receive an award, it can be transferred to another school within the same group of schools (K-8, CCA, or Independent High School). ACHS* awards cannot be transferred to another school.
